JoAnne Freeman, Chris Etchells and Brian Weller from WinGreen Town provided an update on the work of the group and thanked WTC for support:

- Winchcombe Green Trail, 22 June – celebrating gardens for nature and wellbeing.
- Winchcombe School – working together to gain Green Flags and creating a garden for pupils and staff, fundraising has enabled, installed raised beds and hedge, fruit trees. Produce from garden will be used in school kitchen. Reflection area with seating and trellis in progress. Invited Cllrs to visit.
- Water testing project is continuing, results to come once data has been analysed.
- Swifts – 250 nest boxes now installed around town. Asked for reports of sightings of swifts using boxes.
- Pop-up used clothes shop is very successful.
- Toy Library going from strength to strength.

Connect to Work

Connect to Work, funded by the Department for Work and Pensions (DWP), is one of a series of measures designed to support people back into employment.

The Gloucestershire Connect to Work programme aims to help over 2,900 individuals over the next four and a half years who have health conditions or other barriers that make it difficult to find or stay in work.

Gloucestershire is among the first of 47 areas across England and Wales to launch the scheme, which seeks to increase employment levels and boost economic activity.

Current figures show that approximately 17.5% of people aged 16–64 in Gloucestershire are economically inactive — this includes students, early retirees, and others not currently in work. A further 2.6% are unemployed.

The programme is delivered by Gloucestershire County Council through the established Employment and Skills Hub, the frontline access point for employment and training support. The team has a strong track record, having delivered similar programmes for over a decade. To find out more or self-refer:

Grassroots Neighbourhood Fund

A new Councillor-led grant scheme launched on 22 October 2025 to support grassroots initiatives that improve health and wellbeing across Gloucestershire.

The scheme will run for 18 months, and I have up to £20,000 available for projects within the Winchcombe & Woodmancote Division. Grants range from £250 to £5,000.

Eligible projects may include those that:

- Promote health and wellbeing
- Improve access to nature and the environment
- Encourage healthy lifestyles
- Support digital inclusion
- Strengthen neighbourhood safety and cohesion
- Reduce social isolation and loneliness
- Support individuals or groups at higher risk of inequality

Eligible organisations include community groups, voluntary organisations, Town and Parish Councils, charities, CICs, sports groups, schools, academies, and patient-led groups. (For-profit organisations are not eligible.)

Local Government Reorganisation

All seven councils in Gloucestershire have jointly developed two proposals for how local government could be structured in future. In November, councillors across the county will debate the following options:

1. A single unitary authority for the whole of Gloucestershire
2. Two unitary councils:
 - West: Gloucester, Forest of Dean, Stroud
 - East: Cheltenham, Cotswold, Tewkesbury

Gloucester City Council is separately exploring a Greater Gloucester unitary proposal.

All proposals were submitted to the Government by 28 November 2025. The Government is expected to consult residents and stakeholders in early 2026, with a final decision in the summer.

If implemented, elections to the new council(s) are expected in May 2027, with the new structure taking effect from April 2028.

Gloucestershire County Council has published its proposed 2026/27 budget — and there are some big headlines that matter for our communities here in Winchcombe & Woodmancote.

- 🚧 £15 million to improve our roads and make them safer over the next three years.
- 🚧 £2 million for new 20mph zones to protect villages, children and older residents.
- 👶 £21.1 million for a brand-new special school in Gloucester, helping more SEND children learn closer to home.
- ⚡ £2.7 million extra for SEND services, supporting families who have waited far too long.
- 🏡 £57 million investment in three new care homes for older and vulnerable adults.
- 🔥 Over £5 million for Gloucestershire Fire & Rescue, including new frontline vehicles and a new training centre.
- ♻️ £3.9 million to upgrade our recycling centres across the county.

To fund essential services, the proposal includes a 2.99% Council Tax rise plus a 2% adult social care precept — around £6.98 extra per month for a Band D property. The council is also planning £25.7 million in savings by cutting consultants, reducing duplication and improving efficiency.

This budget isn't just numbers — it's a statement of priorities: safer roads, better SEND provision, support for the most vulnerable, and investment in the services our rural communities rely on.

Other Activity of Note

Heartsight CIC

I met with Jonny and Jon from At Heartsight CIC to see their exceptional work supporting children who are struggling emotionally, socially, or academically. Based in Winchcombe, they work with schools, families, and local authorities to deliver nature-based learning, sensory-led therapeutic interventions, and one-to-one support to build resilience and reconnect children with their education.

We also discussed opportunities for them to apply to the Grassroots Fund.

Old Boys School Project

I also met with Gemma Madle to discuss the Old Boys School project and to provide guidance on a potential Grassroots funding application.

Business Breakfast Meeting - Cameron Thomas MP

This week I visited various independent shops, pubs and businesses in Winchcombe to inform and invite business owners in the Tewkesbury constituency, to a post-Budget breakfast at Bishops Cleeve Football Club at 07:00 this Friday, 5 December. Cameron wants to hear what this Budget means for you and your business.

Cllr J Mason asked if the TRO works were completed, if not why not, and when and how will the restrictions be enforced? Cllr Agg has been championing this for WTC, and the Highways Officer has responded that there is no legislation stopping drivers from using SatNav rather than following signage. Will follow up again and press for works to be completed. Foreign language signage cannot be installed without legislation in place to support it. Suggested WTC liaise with TBC on enforcement and consider paying to support additional traffic warden visits.

5 a) Neil Smith from ReformIT in attendance to provide Cllrs with an overview of the protections in place for WTC systems. Alignment with government endorsed Cyber Essentials Standard means that WTC is in top ten percent of best protected organisations. Up to £25k insurance included if WTC meet CES and gains certificate. Circa £1500 per annum.

6. TO CONSIDER A REQUEST FROM LONG SHOTT COFFEE TO FUND THE PURCHASE AND INSTALLATION OF A SECOND PICNIC BENCH IN WINCHCOMBE PARK.

Cathy and Jason gave apologies for not being able to attend. The Clerk explained that they are keen to provide for their customers with a second bench in the same style and adjacent to the current bench. Following discussion members agreed that as WTC funded the current bench and that as the pitch is provided free of charge, it could not justify funding a second table.

Cllr R Parker proposed the bench is not funded, seconded Cllr S Sturgeon.

Cllr D Tarling proposed an amendment that WTC offer to split the cost with Long Shott Coffee by offering a 50% donation towards the costs of purchase and installation, seconded Cllr S Maughan.

Following a vote the proposed amendment was carried.

7. TO RECEIVE AN UPDATE FROM THE ORGANISERS OF PARTY IN THE PARK AND A REQUEST FOR SUPPORT FOR THE 2026 EVENT.

Cllr G Madle left the table.

Presentation received, approx. 3k in attendance, more events taking place, included a wellness tent, marquee for shade/shelter, lawn games and more (all following feedback from previous years), as well as staging and sound, increased catering traders.

All funded by sponsors, including WTC. Event wouldn't happen without this financial support.

Tickets were issued to enable attendance tracking but were still free.

2507 tickets allocated

18 performers

9 catering trailers

28 volunteers on day

153 hours contributed by organising committee

Very positive feedback gathered from survey via Party in the Park website

Donations were gathered during the event along with income from raffle, pitch fees for caterers.

Anticipate costs for 2026 event will be similar to this year.

Actively seeking funding from many other sources, as well as sponsorship but would be very grateful of funding from WTC for next years event.

Cllr J Mason extended appreciation of the event which does so much for the town and bringing people together. Cllr M Lennard noted the level of professionalism in the organising and that the event is an outstanding feature in the community calendar. Cllr S Maughan expressed positive feedback and recognition of efforts in making this event happen.

Cllr S Maughan proposed that £4000 is provided, seconded Cllr S Sturgeon, carried unanimously.

Cllr G Madle rejoined the meeting.

8. TO CONSIDER ANNUAL CPRE MEMBERSHIP RENEWAL.

Proposed Cllr S Sturgeon, seconded Cllr S Maughan, carried unanimously.

9. TO CONSIDER SETTING UP A BIODIVERSITY WORKING GROUP TO DEVELOP AN ACTION PLAN AND POLICY, IN ACCORDANCE WITH SECTION 102 OF THE ENVIRONMENT ACT 2021.

Cllr R Wakeford researched requirements and did not think that WTC needed to set up a working group or develop an action plan. Cllr G Madle commented that at last months meeting it was suggested that WTC work in partnership with others, including WinGreen Town. Cllr J Mason proposed that the model policy available is shared with other groups/organisations for comment, seconded Cllr R Wakeford. Final policy to be reviewed and reported on at Annual Meeting. Carried unanimously.

Healthy habitats - Tewkesbury Borough Council commits to sustainable policies

Tewkesbury Borough Council has taken decisive action at its [council](#) meeting on Tuesday, 18 November 2025. The council adopted two new policies to protect the environment: a peat-free policy and a new pesticide policy. Both sit within the council's 2025 - 2028 plan priority of 'Caring for our environment' and strengthens its response to the climate and ecological emergencies.

The UK Government will ban peat-containing products from 2027, with some exceptions until 2030. Tewkesbury Borough Council is acting earlier, committing to ban the use of peat-containing products - specifically potted plants purchased for council land - by December 2025.

Ubico the council's waste and green space contractor, which carries out most of the council's grounds maintenance and tree planting, will ensure no peat-based compost is used.

The council has also formalised its long-standing practice of avoiding pesticides. The new pesticide policy confirms that harmful chemicals will not be used on council land, protecting biodiversity and public health.

Cllr Cate Cody, Lead Member for Climate and Ecology said: "Peatlands are the UK's largest carbon store, so leaving peat in the ground is vital and this policy ensures that we do just that. Although we have been peat-free for some time, this makes sure that all our contractors adhere to our policy too. We also take the use of pesticides very seriously due to the harm they cause to humans, wildlife, our soil, rivers and more. We are interested in helping our wildlife and ecosystems to thrive and this policy will also strengthen this."

While the council does not own farmland, it will signpost interested landowners to alternative pest control methods and resources such as [Pesticide Action Network](#).


