- 2. DECLARATIONS OF INTEREST. None.
- 3. TO RECEIVE MATTERS ARISING FROM PREVIOUS MEETING.

Football Goal Posts	Cllr J Mason and a rep from Winchcombe Youth Football Club to schedule date for installation contractors to revisit and re-site.
Maintenance Contract	New contractor has been selected; however current contractor has stated that WTC are bound by their terms until March 2026. The new contractor is happy to wait but there will likely be an increase to their prices. WTC could seek legal advice to explore getting out of current contract early, but this will be costly and not necessarily result in the desired outcome. Playing Fields Committee discussed and agreed to wait until next year to commence to the new contract.
Pump Track	New contractor has been appointed due to failings of previously appointed contractor. Installation to commence October 2025.

New maintenance contractors to be asked to complete additional tree planting (as per planning conditions) once track installed. Clerk to action.

Longer term potential for bridge over river Isbourne to provide public access – further discussion/exploration required.

## 9. TO CONSIDER TENDERS RECEIVED AND APPOINT A CONTRACTOR TO INSTALL A

TODDLER PLAY AREA IN WINCHCOMBE PARK.

Members reviewed tender submissions, but had questions around how this could be funded, as the majority of CiL funding has now been committed to possible use for the Old Boys School Youth Centre project. Some money available in Winchcombe Park earmarked reserve and members also discussed possible fundraising/grant opportunities.

Members agreed that £40,000 be designated from Winchcombe Park earmarked reserve to support bid applications.

Members proposed that £30,000 could come from the Tourism earmarked reserve.

No decision on supplier to be made at this stage, as remaining funds need to be sought.

## 10. TO CONSIDER QUOTATIONS FOR QUARTERLY OPERATIONAL INSPECTIONS OF ALL PLAY EQUIPMENT.

Following discussion members agreed to instruct The Play Inspection Company, to commence in 2026.
